Par.: Cynnig i gynyddu capasiti Ysgol Chwilog o 65 i 95 o ddysgwyr ar 1 Medi 2023

Ar ddydd Mawrth, 24 Ionawr 2023 penderfynodd Cabinet Cyngor Gwynedd gyhoeddi rhybudd statudol a chynnal cyfnod gwrthwynebu ar y cynnig 'i gynyddu capasiti Ysgol Chwilog o 65 i 95 o ddysgwyr drwy ychwanegu dosbarth o 1 Medi 2023'.

Yn unol â'r penderfyniad, cyhoeddwyd rhybudd statudol a chynhaliwyd cyfnod gwrthwynebu rhwng 8 Chwefror ac 8 Mawrth 2023. Ni dderbyniwyd unrhyw wrthwynebiad i'r cynnig yn ystod y cyfnod gwrthwynebu.

O ganlyniad, ar 15 Mai 2023, penderfynwyd cymeradwyo'r cynnig uchod drwy [Daflen Benderfyniad](#) a gyhoeddwyd gan Aelod Cabinet Addysg, Cyngor Gwynedd.

Wrth benderfynu ar y cynnig, bu i'r asesiadau canlynol gael eu hystyried yn unol â gofynion y Cod Trefniadaeth Ysgolion (11/2018): *Cydraddoldeb, y Gymraeg ac anfantais economaidd-gymdeithasol, Llesiant, y gymuned, Ansawdd a safonau addysg, a Threfniadau teithio.*

Amlinellir isod y rhesymau dros gymeradwyo'r cynnig, yn unol â'r ffactorau penodol a nodir yn adrannau 1.3 i 1.6 o'r Cod Trefniadaeth Ysgolion 2018:

Ansawdd a safonau mewn addysg:

- Mynegodd Estyn mewn ymateb i'r ymgynghoriad statudol y byddai'r "cynnig yn debygol o gynnal y safonau cyfredol o leiaf o ran addysg, darpariaeth ac arweinyddiaeth a rheolaeth".
- Rhagwelir y bydd gweithredu'r cynnig i gynyddu capasiti'r ysgol drwy greu dosbarth ychwanegol yn cefnogi'r ysgol i wella ansawdd a safonau mewn addysg am y rhesymau a ganlyn:
 - i. bydd yn cynnig gwell amgylchedd dysgu i staff addysgu a dysgwyr yr ysgol
 - ii. bydd dysgwyr yr ysgol yn derbyn gwell profiadau addysgol a chyfleoedd
 - iii. bydd dysgwyr yn cael eu haddysgu mewn dosbarthiadau gyda niferoedd mwy addas

Yr angen am leoedd a'r effaith ar hygyrchedd ysgolion:

- Bydd gweithredu'r cynnig yn arwain at ychwanegu dosbarth yn Ysgol Chwilog, ac o ganlyniad byddwn yn gallu cynnig lle i fwy o blant y dalgylch mewn dosbarthiadau addas o'r maint cywir.
- Yn Medi 2022, roedd 84 dysgwr yn yr ysgol, a chapasiti'r ysgol yn 65. O ganlyniad i weithredu'r cynnig bydd capasiti ar gyfer 95 o ddysgwyr Derbyn i Blwyddyn 6 gydag 13 lle meithrin rhan amser.

O ganlyniad, bydd plant y dalgyrch yn gallu derbyn addysg yn eu cymuned, gan gyfrannu at ffyniant yr iaith Gymraeg mewn ardal o arwyddocâd ieithyddol.

Dear Stakeholders,

Re.: *Proposal to increase the capacity of Ysgol Chwilog from 65 to 95 learners on 1 September 2023*

On Tuesday, 24 January 2023, Cyngor Gwynedd's Cabinet decided to publish a statutory notice and hold an objection period on the proposal 'to increase the capacity of Ysgol Chwilog from 65 to 95 learners by adding a class from 1 September 2023'.

In accordance with the decision, a statutory notice was issued and an objection period was held between 8 February and 8 March 2023. No objection was received to the proposal during the objection period.

As a result, on 15 May 2023, it was decided to approve the above proposal through a [Decision Notice](#) published by the Education Cabinet Member, Cyngor Gwynedd.

When deciding on the proposal, the following assessments were considered in accordance with the requirements of the School Organisation Code (11/2018): *Equality, the Welsh language and socio-economic disadvantage, Well-being, the community, Quality and standards of education, and Travel arrangements.*

Outlined below are the reasons for approving the proposal, in accordance with the specific factors set out in sections 1.3 to 1.6 of the School Organisation Code 2018:

Quality and standards of education:

- Estyn stated in response to the statutory consultation that the "*proposal would be likely to maintain the current standards at least in terms of education, provision and leadership and management*".
- It is anticipated that implementing the proposal to increase the school's capacity by creating an additional class will support the school to improve quality and standards in education for the following reasons:
 - i. it will offer a better learning environment for the school's teaching staff and learners
 - ii. the school's learners will receive better educational experiences and opportunities
 - iii. learners will be taught in classes with more suitable numbers

The need for places and the impact on school accessibility:

- The implementation of the proposal will lead to the addition of a classroom at Ysgol Chwilog, and as a result we will be able to offer a place to more children in the catchment area in suitable classes of the right size.
- In September 2022, there were 84 learners in the school, and the school's capacity was 65. As a result of implementing the proposal there will be capacity for 95 Reception to Year 6 learners with 13 part-time nursery places.

Education resources and other financial implications:

- This proposal is attached to the recent capital investment to add a classroom to Ysgol Chwilog.
- By adding a classroom and increasing the school's capacity, additional places can be ensured for teaching the catchment area's children in suitable classes of the right size.

Other general factors:

- It is anticipated that increasing the capacity of Ysgol Chwilog will have a positive impact on equality, the Welsh language and socio-economics by creating additional places for primary school children in the catchment area, creating a solid infrastructure for the community and creating the best conditions for the Welsh language and the prosperity of the community. As a result, children in the catchment area will be able to receive education in their community, contributing to the prosperity of the Welsh language in an area of linguistic significance.
